#### 1.Update since last meeting

Matarvattenkonferensen 2017

A very good conference, and a good introduction to SIAPWS. Matarvattensektionen EC agrees that we must keep on mentioning SIAPWS at the conference to get people interested.

Trial with ODA at Reno Nord – even though it works in the steam cycle, the ODA is now affecting the analyzing equipment, the IEX resin is contaminated, and the degasser is contaminated showing high values of degassed conductivity.

## 2. SIAPWS Water Chemistry Network

2.1. Planning of "Base Course in Power Plant Chemistry" in 2018

Karsten has written an article for the Matarvattensektionen News Letter advertising for the courses planning in 2018. Jere will send a picture to Karsten, that goes in to the article.

The presenters must come up possible dates for the courses in 2018 (the first three at least). The courses should not be too close to other activities in SIAPWS/Matarvattensektionen/ADV.

- Valmet presentation on flue gas condensation not commercial (Arja Lehikoinen from Walmet is a new member of SIAPWS).
