2. Annual report of the chair

Karsten went thought the annual report (see Appendix 1).

2018 has been a very active year:

- Good annual meeting at Söderenegi AB, Igelstaverket in 2018 with app. 16 participants
- EC workshop in Helsinki, Finland, where challenges with the Nordic collaboration was discussed.
- It was decided to establish national subgroups, with Matarvattensektionen representing Sweden, and establish two new national groups, SIAPWS Suomi and SIAPWS Danmark.
- 2018 has been the year where the two new national subgroups have been established.
- There have been two Online courses in 2018, and we have achieved a balance between the cost spent on the courses and the income from the participant fee.
- ICPWS-17 2018 in Prague. SIAPWS had prepared two sessions on flue gas condensate and the reuse of condensate, which was a great success.

3. The Financial situation.

SIAPWS pays for the Chairperson attending the IAPWS annual meeting.

Matarvattensektionen

Roger Lundberg (consultant, chair of Matarvattensektionen) presented the work done in the Swedish Matarvattensektionen.

Matarvattensektionen has existed since 1986 and has arranged the Matarvattenkonferensen ever since.

This year's Matarvattenkonferensen will be held on 6.-7. November 2019 in Stockholm.

Annual Member fee is 2800 SEK (250 EUR), and there is just one type of fee.

10. Workshop

The workshop consisted of 4 very interesting presentations. The main topic of the workshop was district heating.

Monika Nielsen from Ørsted in Denmark went through the experience with inspection of a hot water storage tank using a robot (see Appendix 3).

Thomas Dalsgaard from Silhorko EUROWATER presented the Danish District Heating recommendation for water chemistry (see Appendix 4).

Ville Rantanen, Teollisuuden Vesi presented the use om a membrane contactor for the removal of CO₂ from makeup water (see Appendix 5).

Karsten Thomsen, COWI introduced the first thoughts of an IAPWS Technical Guidance Document on Flue Gas Condensation and re-use of the condensate (see Appendix 6).
