The Ordinary General Meeting was held as a Skype meeting due to COVID-19. In total 15 members joined the meeting, four from Finland, five from Sweden and six from Denmark.

1. Election of moderator and clerk of minutes

2. Annual report of the chair

The annual report was circulated prior to the meeting.

2019 has been a very active year:

- The national groups in Denmark and Finland have been started up.
- A year of consolidation.

Contact Person:

- Not much done at the Nordic level, due to activities in the national groups.
- Between 25-30 members of the two new national groups. In comparison, Matarvattensektionen has slightly more than 100 members.
- Focus in Finland is to get more contact to and members from the heat and power companies.
- In Denmark most of the members are heat and/or power producers. Quite a few district heating companies have joined the Danish group.

- The annual meeting of IAPWS was arranged by the Canadian organisation in Banff. Karsten, Arja, Anders and Monika attended the meeting.
- The annual meeting in SIAPWS was organised by SIAPWS Suomi and was well organised.

3. Update of SIAPWS Statutes

A proposal for new Statutes has been circulated prior to the meeting.

A new section on the Nordic Collaboration has been added.

The membership is now only the three national organisations and some group (large companies or sponsors) members. SIAPWS Suomi has changed name to Vesikemiayhdistys SIAPWS Suomi ry, and this will be changed in the Statutes.

There is a possibility for companies to become a sponsor for SIAPWS. They will join the Nordic organisation as a group member and will be offered a seat in the EC, if they wish to participate on that level

The election of members for the EC has been changed to two members from each country nominated by the EC of the national groups. Each group member of SIAPWS may nominate one EC member.

The SIAPWS Vision and Mission are added to the Statutes as Appendices.

Karsten went through the SIAPWS Vision and Mission – no comments from the members.

There were no objections to the new Statutes at they were approved by the members and will be circulated with the Minutes. (see the new and approved Statutes in Appendix 2 and the appendices in Appendix 3).

4. The Financial situation

Report of the Financial situation

SIAPWS Cashier (Monika Nielsen) went through the financial situation (see Appendix 4).

SIAPWS pays for the chairperson attending the IAPWS annual meeting.

We must save money for arranging the annual IAPWS meeting at some point in the future. The next time for SIAPWS to host the annual IAPWS Meeting most probably will be in 4-5 years.
